Completion of the Consensus Paper

Many of you probably already know this; the consensus paper outlining the six key principles of community mental health care is finalized and even translated in Japanese and French (thanks to our partners). According to EUCOMS quality community mental health care is based on human rights (1), works with a public health perspective (2), supports recovery of clients (3), provides effective interventions (4), has a network approach (5), and uses peer experience as a source of expertise (6). We expect to publish our first scientific article this year based on the consensus paper. We will keep you updated. [Here](#) you find the complete consensus paper.

Strengthening collaboration with IIMHL, MHE & IMHCN

There are a number of networks active in Europe in the field of mental health care. Important networks that complement the work of EUCOMS as the representative of mental health care service providers in

Europe are; the International Initiative for Mental health Leadership ([IIMHL](#)), Mental Health Europe ([MHE](#)) and the International Mental Health Collaborating Network ([IMHCN](#)). EUCOMS has in the last year sought, and still seeks engagement with these important players to support each other's mission to eventually improve access to quality community mental health care services for all citizens in Europe.

Learning and Exchange visits

The first learning and exchange visits take place this summer between mental health care service providers from Belfast, Verona, Oslo and Màlaga. The purpose of these site-visits is to learn from different services about how they think, act and work in order to bring in practice the principles of good community mental health care as described in the 'Consensus Paper on Fundamental Principles of Community Based Mental Health Care'. As a guidance they use the [exchange tool](#) that has been developed for this purpose. The service providers will report their findings at the next EUCOMS meeting in Màlaga coming October. What can EUCOMS do for you?

Coming October in Màlaga we want to present to you the statutes of the network to discuss and find agreement on the government- and financial structure and the services that we provide. We decided to make a distinction between the different stakeholder groups; service providers and umbrella organisations (partners), service users and their carers (collaborators), knowledge institutes (collaborators) and policy makers (collaborators). Each stakeholder can benefit from involvement in the network:

Service Providers and Umbrella Organisations

EUCOMS connects you with other service providers across Europe and facilitates mutual learning and support on the implementation of quality community mental health service providers. Moreover, EUCOMS represents you and other community mental health service providers on the national and international level to advocate for better community mental health care across Europe.

Service Users and their Carers

One of the six key principles of quality community mental health care described by EUCOMS is that services should be shaped in collaboration with service users (including professionals) tapping into their experience and expertise. EUCOMS facilitates this collaboration and connects you with European service providers who are eager to use this source of expertise and want to learn

how to improve their services. Moreover, EUCOMS advocates on national and international level for the implementation of quality community mental health care services benefitting the citizens of Europe in needs of such services.

Knowledge Institutes

EUCOMS connects you with service providers and their users across Europe to develop research projects and to disseminate research results supporting the implementation of quality community mental health care in Europe, narrowing the gap between research and practice. Moreover, EUCOMS advocates for quality community mental health care on national- and international policy level also stressing the need for more knowledge on what ‘quality’ entails and how quality community mental health care could be best implemented.

Policy Makers

EUCOMS connects you with services providers their users and facilitates learning about the challenges and opportunities for the implementation of quality community mental health care in practice in a variety of European countries. Also, you will be connected with knowledge institutes specialised in this field. Both the academic and practical knowledge would be of use to inform you to develop evidence-based policy and to narrow the gap between policy and practice.

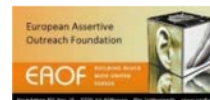

It has over 2,000 employees in 14 locations, whose work encompasses approximately 1.4 million people in the Palatinate.

Mental Health Resource Spotlight in Central and Eastern Europe

In many countries in Central and Eastern Europe, large psychiatric or social care institutions are still the main care setting for those deemed to require long-term support, despite years of stated policies in support of a process of deinstitutionalisation. Right now, there are hundreds of thousands of persons with intellectual and psychosocial disabilities effectively caught between the stated policy goal of moving away from institutional care and a lack of effective means to bring about that change. The result is that many such institutions are run down, poorly maintained and too often the setting for practices that are inhumane or antithetical to safe, effective, high-quality care. This issue has been recently and extensively evidenced by a number of recent international reports that are highlighted in this article.
