## Report first EuCoMS network meeting available

On 5 and 6 April 2016, 35 participants representing 13 countries met each other for the first *EuCoMS* network meeting. GGZ Nederland – the Dutch sector organisation of mental health service providers – hosted a wonderful dinner in the “Trog” to kick-off the meeting. On April 6<sup>th</sup>, the group worked very hard to lay a solid foundation under the *EuCoMS* network. After the kick-off meeting GGZ Noord-Holland-Noord – a mental health services organisation in the Netherlands – hosted two shadow sessions in Flexible Assertive Community Treatment teams in the cities of Heiloo and Alkmaar.

## **Towards consensus about community based mental health services: first steps**

The consensus document on community mental health is the first major activity of EuCoMS. Guido Pieters has offered to take the lead in this important project. The project will start in July aiming to finish the draft version by the end of September 2016, well before the next Network meeting. We will keep you informed about the process in our next newsletter.

## **Organisation of the network**

The network will work with a steering group. The important role of peer experts is emphasised with two dedicated seats. The steering group will mainly meet through skype meetings, conference calls and email, face to face meetings will be limited to EuCoMS Network meetings. In Heiloo it was decided there is no need for a separate advisory board. All participants will have the opportunity to give feedback and advice.

## **COST Application**

Just before the deadline on April 25<sup>th</sup>, the secretariat successfully submitted the application for a COST Grant. This grant would provide EuCoMS a small amount of funding over a period of 4 years, covering costs for travel, meetings and congresses and other content driven activities.

We will be able to share the application with you after COST has made a decision. The final decision regarding the approval and funding is expected at the end of October 2016. For now we can provide just a glimpse.

Following up the discussion at the network meeting about planning, these are the proposed activities:

- Create a consensus document on key components community mental health services
- Develop an implementation toolkit and repository for services and stakeholders
- Develop, collect and present quality indicators for community mental health services
- Develop a methodology for needs assessment on a community level
- Strengthen peer expert leadership
- Engage with European decision makers
